**Building & Code Enforcement Officer:** Issued 9 building permits; 34 inspections

**Assessor's Report:** Presentation by County Assessor on Reassessment of properties within Perrysburg Township. Plan for cyclical reassessments (RP-1573-ACR-P) and memorandum of understanding were left for signatures. Deadline is June 24, 2022

**Water Dept. Report:** Perrysburg processed 1,259,708 gallons for a daily average of 41,190 gallons; 9 UFPO and 6 work orders. Versailles used 173,741 gallons over the month of April for a daily average of 5,700 gallons per day

**Sewer Report:** No Report

**Highway Supt. Report:** Mowing roadsides with excavator; finished roadside cleanup; Auctions International took pictures of equipment; cold patching holes as needed; ready to start skid paving; gave status of sold equipment

**Justice Report:** Judge Dankert closed the following cases for the month of April: 30 V/T, 1 Penal Law and 56 Animal Control. Total Reported to State Comptroller \$4056.

**Dog Control Officer's Report:** 3 dogs loose on Peck Hill – gave warning; 1 dog loose on Markham Drive – gave warning; 1 stray on Planck Road – took to SPCA; 1 stray on North Road; missing lab on Jolls Road, missing bully on VanVleck Road; 1 barking ticket issued on Peck Hill; 12 delinquent notices

**Town Clerk Report:** Town Clerk collected \$3,295.65 for the month of April. \$2007.98 was the town portion paid to the Supervisor
